FINAL ORDER OF THE BOARD




IT IS HEREBY ORDERED that the Complaint filed in LCB case number 22,763 is sustained and within 30 days of the date of this Order, the Licensee shall pay a monetary penalty of \$1750.00 to: Washington State Liquor Control Board, 2715 Saint Andrews Loop, Suite B, Pasco, WA 99301-3386. In the event that the Licensee does not make a full and

1 timely payment of the monetary penalty, then the Licensee shall serve a five (5) day
2 suspension of its liquor license, the dates and time of which shall be set by the Washington
3 State Liquor Control Board.

MCKENNA, Attorney General and RUTH AMMONS, Assistant Attorney General and the Licensee YELLAHAMMER, INC. d/b/a TOWNE CRIER, represented by PAUL CHARTRAND (Licensee), hereby enter into this stipulated settlement agreement for case number 22,763.

I. INTRODUCTION

The Washington State Liquor Control Board charged the above-named Licensee in its Complaint dated July 31, 2007, with the following violation of the Washington State Liquor Act and/or Revised Rules and Regulations of the Board:

On or about May 26, 2007, the above-named licensee, or employee(s) thereof, did permit a person apparently under the influence of liquor to physically possess or consume liquor on the licensed premises, contrary to WAC 314-16-150.
