STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (“Enforcement”) represented by its attorneys ROBERT M. MCKENNA, Attorney General and KATE REYNOLDS, Assistant Attorney General and the Licensee, Ale and Lager Enterprises, Inc. d/b/a Skagit River Brewing Company, (“Licensee”), hereby enter into this stipulated settlement agreement for Liquor Control Board Case Numbers 22,766 and 22,767.

I. INTRODUCTION

The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 076E017 (“AVN”) on March 15, 2007, to the above-named Licensee with the following violations:

Failure to submit monthly tax reports as required by WAC 314-19-015 and WAC 314-19-020 for August and December 2006.

The Washington State Liquor Control Board Education and Enforcement Division issued AVN No. 076E024 on June 12, 2007, to the above-named Licensee with the following violations:

Failure to submit monthly tax reports as required by WAC 314-19-015 and WAC 314-19-020 for January, February and March 2007.

Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced AVNs.

II. AGREEMENT OF THE PARTIES

Enforcement and the Licensee agree to the following:

1. Enforcement and the Licensee enter into this agreement to avoid the time and expense of further litigation. The Licensee explicitly waives the right of further administrative review of all matters related to this violation. The Licensee hereby voluntarily withdraws its request for a hearing on the matter.

2. The Licensee admits to the violations in the above-referenced AVNs.

3. The Licensee agrees to pay a monetary penalty of two thousand dollars (\$2,000); this amount shall be paid within thirty (30) days of the date of the final order of the Washington State Liquor Control Board. Payment shall be made to the Washington State Liquor Control Board no later than 4:00 p.m. on the applicable date. In the event that the Licensee does not make a timely payment, then and in that event, the Licensee shall serve a twenty (20) day suspension of its liquor license, the dates and time of which shall be set by the Washington State Liquor Control Board.

4. The parties recognize that this settlement agreement is subject to approval by the Washington State Liquor Control Board.


