

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division ("Enforcement") represented by its attorneys ROBERT M. MCKENNA, Attorney General, and THEODORE M. MILLER, Assistant Attorney General, and the Licensee, 7-ELEVEN, INC., d/b/a 7-ELEVEN 2303-18653H ("Licensee"), of Lacey, Washington, represented by its owner, 7-ELEVEN, INC., hereby enter into this stipulated settlement agreement for case number 22,779.

I. INTRODUCTION

The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 1F7179I ("AVN") on July 13, 2007, to the above-named Licensee with the following violations of the Washington State Liquor Act:

1 On or about June 28, 2007, the above named Licensee, or an employee(s) thereof, did
2 sell, give, or otherwise supply liquor to a person under the age of 21 years contrary to RCW
3 66.44.270(1).

4 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
5 above-referenced AVN.

6 **II. AGREEMENT OF THE PARTIES**

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this agreement to avoid the time and
9 expense of further litigation. The Licensee explicitly waives the right of further administrative
10 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its
11 July 17, 2007 request for a hearing on the matter.

12 2. The Licensee admits to the above-referenced complaint. On or about June 28,
13 2007, an employee of the Licensee sold alcohol to a person under 21 years of age in violation
14 of RCW 66.44.270 and WAC 314-11-020(1).

15 3. As a second violation for sale of alcohol to a minor, the parties agree that the
16 penalty for the above violation shall be a five (5) day suspension of the Licensee's liquor
17 license. The suspension shall occur on dates set by the Board in its Final Order.

18 4. The parties recognize that this settlement agreement is subject to approval by
19 the WASHINGTON STATE LIQUOR CONTROL BOARD.






