STIPULATION, SETTLEMENT  
AGREEMENT AND ORDER OF  
DISMISSAL

STIPULATION AND SETTLEMENT AGREEMENT

COMES NOW, Respondent Washington Liquor Control Board, by and through its attorneys, ROBERT M. MCKENNA, Attorney General and RUTH AMMONS, Assistant Attorney General, and Claimant HYUNG IL KWON, by and through his attorney, YOUNG HAN, and hereby enter into the following Stipulation and Settlement Agreement:

1. Claimant HYUNG IL KWON withdraws his claim to the 4,462 Cases of Loose Leaf Tobacco, Chewing Tobacco, Cigars, Blunt Wraps, and Cigarettes seized by agents of the Washington State Liquor Control Board on April 5, 2007, in Pierce County, Washington.

2. The above-captioned forfeiture proceeding relating to the claim of HYUNG IL KWON to the above-referenced property shall be dismissed with prejudice and without assessment of costs or fees to either party.

3. No taxes, penalties or interest of any nature shall be assessed against HYUNG IL KWON with regard to the 4,462 Cases of Loose Leaf Tobacco, Chewing Tobacco, Cigars,


1 Blunt Wraps, and Cigarettes seized by agents of the Washington State Liquor Control Board  
2 on April 5, 2007, in Pierce County, Washington.

3 4. This Stipulation and Settlement Agreement shall not preclude any criminal  
4 actions that may or have been filed against any parties and that relate in any way to the seizure of  
5 the tobacco products at issue in this forfeiture proceeding.




23 **ORDER**


