

The Washington State Liquor Control Board Education and Enforcement Division ("Enforcement") represented by its attorneys ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, LORD CORNWALL RESTAURANT, INC, d.b.a. DOWNTOWN JOHNNY'S RESTAURANT AND NIGHTCLUB. ("Licensee") represented by JEFFREY A. THIGPEN, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 22,812.

I. INTRODUCTION

The Washington State Liquor Control Board charged the above-named Licensee in its Administrative Violation Notice (AVN) No. 3B7276A dated December 26, 2007, with the following aggravated violation of the Washington State Liquor Act:

The Licensee admits that on or about October 3, 2007, an employee of the Licensee, violated Title 9A.76.020 RCW (Obstructing a Law Enforcement Officer) in violation of WAC 314-11-015(2).

1 The Licensee admits that on or about October 3, 2007, an employee of the Licensee,
2 violated Title 9A.76.020 RCW (Obstructing a Law Enforcement Officer) in violation of
3 WAC 314-11-015(2).

4 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
5 above-referenced AVN.

6 II. AGREEMENT OF THE PARTIES

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this agreement to avoid the time and
9 expense of further litigation. The Licensee explicitly waives the right of further administrative
10 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its
11 request for a hearing on the matter.

12 2. This agreement constitutes the final written expression of all the terms of this
13 agreement and is a complete and exclusive statement of these terms.

14 3. The Licensee admits to the violation set forth in the above-referenced
15 Complaint. On October 3, 2007, an employee of the Licensee, violated Title 9A.76.020 RCW
16 (Obstructing a Law Enforcement Officer) in violation of WAC 314-11-015(2).

17 4. The parties agree that the aggravated penalty for this first violation of an
18 employee of the Licensee violating Title 9A.76.020 RCW (Obstructing a Law Enforcement
19 Officer) in violation of WAC 314-11-015(2) is a 5 day suspension or a monetary penalty of
20 \$2,500.

21 5. The Licensee agrees to pay a monetary penalty of one thousand five hundred
22 dollars (\$1,500). The Licensee shall pay the monetary penalty in three (3) separate payments
23 of five hundred dollars (\$500) each. The first payment of five hundred dollars (\$500) shall be
24 made no later than thirty (30) days after the date of the Final Order of the Board. The second
25 payment of five hundred dollars (\$500) shall be made no later than sixty (60) days after the
26 date of the Final Order of the Board. The final payment of five hundred dollars (\$500) shall be

1 made no later than ninety (90) days after the date of the Final Order of the Board. Payments
2 shall be made to the Washington State Liquor Control Board no later than 4:00 p.m. on the
3 applicable dates. Payment shall be sent to:



6 6. In the event that the Licensee does not make full and timely payments on the
7 monetary penalty as required in Section II, Paragraph 5, then the penalty of a 5-day suspension
8 of the Licensee's liquor license shall be imposed.


9 7. The parties recognize that this settlement agreement is subject to approval by
10 the Washington State Liquor Control Board.
