



The Washington State Liquor Control Board Education and Enforcement Division (“Enforcement”) represented by its attorneys ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, WILSON ENTERTAINMENT GROUP LLC d.b.a. MOON SPORTS BAR (“Licensee”) represented by PAUL NELSON, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 22,821.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee in its Administrative Violation Notice (AVN) No. 2L8018A issued January 24, 2008, with the following violation of the Washington State Liquor Act:

On or about January 18, 2008, the above-named Licensee or employee(s) thereof, supplied liquor to a person under twenty-one (21) years of age, contrary to RCW 66.44.270(1).

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced AVN.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation. The Licensee explicitly waives the right of further administrative
7 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its
8 request for a hearing on the matter.

9 2. This agreement constitutes the final written expression of all the terms of this
10 agreement and is a complete and exclusive statement of these terms.

11 3. The Licensee admits to the violation set forth in the above-referenced AVN. On
12 January 18, 2008, the Licensee or employee(s) thereof supplied liquor to a person under
13 twenty-one (21) years of age, contrary to RCW 66.44.270(1).

14 4. The parties agree that as a first violation for supplying liquor to a person under
15 twenty-one (21) years of age, the standard penalty is a five (5) day suspension of the
16 Licensee's liquor license or a five hundred dollar (\$500) monetary penalty.

17 5. The Licensee agrees to pay a total monetary penalty of three hundred dollars
18 (\$300) for the above-referenced AVN and the violation charged therein. This amount shall be
19 paid within thirty (30) days of the date of the final order of the Washington State Liquor
20 Control Board. Payment shall be made to the Washington State Liquor Control Board no later
21 than 4:00 p.m. on the applicable date.

22 6. In the event that the Licensee does not make a timely payment, as required by
23 Section II, Paragraph 5, the Licensee shall serve a five (5) day suspension of its liquor license,
24 pursuant to WAC 314-29-020; the dates and time of which shall be set by the Washington
25 State Liquor Control Board.





