INVESTIGATIVE SUMMARY

On 2-09-08 at approximately 2044 Franklin County Sheriff Deputies Ruben Bayona, Travis Rogers and Travis Mahler entered the licensed premises after being dispatched to the premises. Dispatch indicated to the Deputies that a complaint had been received that a person under 21 was drinking in the premises. The Deputies entered the lounge portion of the premises. The licensee was in the lounge. The Deputies contacted the licensee. The Deputies contacted Mario Javier Diosdado Perez (DOB 3-31-87) in the lounge. It was established through Perez's identification that he was under the age of 21. Perez told the deputies that he had not drank any alcohol. Perez said that he was in the lounge to watch TV and had been there for a while. The Deputies contacted the licensee after identifying Perez and told him that persons under 21 could not be in the lounge.

WAC/RCW:

**RCW 66.44.310**

Minors frequenting off-limits area — Misrepresentation of age — Penalty — Classification of licensees. (Effective until July 1, 2008.)

(1) Except as otherwise provided by RCW 66.44.316 and 66.44.350, it shall be a misdemeanor:

(a) To serve or allow to remain in any area classified by the board as off-limits to any person under the age of twenty-one years;

(b) For any person under the age of twenty-one years to enter or remain in any area classified as off-limits to such a person, but persons under twenty-one years of age may pass through a restricted

area in a facility holding a spirits, beer, and wine private club license;

(c) For any person under the age of twenty-one years to represent his or her age as being twenty-one or more years for the purpose of purchasing liquor or securing admission to, or remaining in any area classified by the board as off-limits to such a person.

(2) The Washington state liquor control board shall have the power and it shall be its duty to classify licensed premises or portions of licensed premises as off-limits to persons under the age of twenty-one years of age.


