

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (“Enforcement”) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and JENNIFER ELIAS, Assistant Attorney General, and the Licensee, Norman Myrick, owner of Frenchman Hills Winery (“Licensee”), hereby enter into this stipulated settlement agreement for LCB Case Number 22,840.

I. INTRODUCTION

Enforcement issued administrative violation notice (AVN) number 6D7345D to the above-named Licensee on January 23, 2008, which alleged that the Licensee accepted a loan from a retail licensee in violation of WAC 314-12-140(3) in November of 2007.

Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced AVN.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. Enforcement and the Licensee enter into this agreement to avoid the time and
4 expense of further litigation. The Licensee explicitly waives the right of further administrative
5 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its
6 request for a hearing on the matter.


7 2. The Licensee admits to the above-referenced AVN. In November of 2007, the
8 Licensee, a winery, accepted a loan from the retailer CENEX (liquor license number 369764)
9 in the sum of \$93,600.

10 3. In exchange for the Licensee's stipulation to AVN 6D7345D, Enforcement is
11 waiving the standard penalty of \$1,000 for a violation of WAC 314-12-140. Based on the
12 Licensee's stipulation and the fact that the Licensee no longer holds liquor license number
13 400092, Enforcement agrees not to impose the penalty indicated on Administrative Violation
14 Process, which was the amount of the loan (\$93,600).

15 4. The parties recognize that this settlement agreement is subject to approval by
16 the Washington State Liquor Control Board.
