STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, ONE MORE TIME, INC. d/b/a THE SEATTLE EAGLE (Licensee) through its attorney, DAVID OSGOOD, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 22,875.

I. INTRODUCTION

1. The Washington State Liquor Control Board, by Complaint dated March 16, 2009, alleged that the Licensee, or an employee(s) thereof, did allow or permit persons to engage in lewd conduct, contrary to WAC 314-11-050(2)(a). The Complaint alleges that all of the relevant acts occurred on or about September 27, 2008.

1 7. The Licensee shall pay the monetary penalty of one thousand dollars (\$1000) no
2 later than thirty (30) days after the date of the Final Order of the Board. Payment shall be sent

7 8. In the event that the Licensee fails to make full and timely payment of the
8 monetary penalty as required in Section II, Paragraph 6, the Licensee shall serve a five (5) day

10 State Liquor Control Board.


11 9. The parties recognize that this settlement agreement is subject to approval by


