The above captioned matter coming on regularly before the Washington State Liquor Control Board (Board) and it appearing:

1. That on December 9, 2009^{8/4/09} The Board's Enforcement and Education Division issued Administrative Violation Notice (AVN) No. 2N8340B alleging that on or about December 5, 2008, Bob's K Corp d/b/a Andy's Restaurant and Lounge (Licensee) or employee(s) thereof, gave, sold or otherwise supplied liquor to a person under twenty-one (21) years of age, contrary to RCW 66.44.270(1).
2. That on June 5, 2009 the Licensee formally withdrew its request for an administrative hearing in this matter.
3. That the Licensee has sold its business to an outside party, and acknowledges it no longer has a business interest in the license at issue.
4. The Board has approved the assumption of liquor license No. 358338 to that same outside party that purchased the Licensee's business.

5. That in withdrawing its request for hearing the Licensee voluntarily and knowingly admits to the violation as charged in AVN No. 2N8340B.

6. That the entire record in this proceeding was presented to the Board, and the Board having fully considered said record and being fully advised in the premises; NOW THEREFORE:

IT IS HEREBY ORDERED: that the violation charged in AVN No. 2N8340B is sustained and the Licensee or employee(s) thereof, gave, sold or otherwise supplied liquor to a person under twenty-one (21) years of age, in violation of RCW 66.44.270(1). IT IS FURTHER ORDERED: that the Licensee's sale of its business and release of any interest or right it has in liquor license No. 358338 will be in lieu of any penalty for the admitted violation.
