
IT IS HEREBY ORDERED that AVN Number 3H9014B for Case Number 22,899 is sustained and within sixty (60) days of the date of this Order, the Licensee and its employees attend a responsible liquor and tobacco sales class, or if employees have already attended a responsible liquor and tobacco sales class in 2009, provide proof of such attendance; and


1 within thirty (30) days of this order, the Licensee shall pay a monetary penalty of three

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and JENNIFER ELIAS, Assistant Attorney General, and the Licensee, AMAN INTERNATIONAL, INC., d/b/a SHELL MARKET (Licensee) through its representative KULVINDER JOHAL, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 22,899.

I. INTRODUCTION

1. The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 3H9014B ("AVN") on January 22, 2009, to the above-named Licensee specifying the following violation of the Washington State Liquor Act:

On or about January 14, 2009, the above-named Licensee, or an employee(s) thereof, sold, gave, or otherwise supplied alcohol to person under twenty-one years of age contrary to RCW 66.44.270(1).

1 6. If the Licensee subsequently fails to make a full and timely payment of the
2 penalty as required in Section II, Paragraph 4, then the standard penalty of a five (5) day
3 suspension of the Licensee's liquor license shall be imposed.

4 7. The Licensee and its employees shall attend a responsible liquor and tobacco
5 sales class within sixty (60) days of the final order of the Board, or if employees have already
6 attended a responsible liquor and tobacco sales class in 2009, provide proof of such attendance
7 within sixty (60) days of the Board's final order.

8 8. The parties recognize that this settlement agreement is subject to approval by
9 the Washington State Liquor Control Board.

10 9. This agreement constitutes the final written expression of all the terms of this
11 agreement and is a complete and exclusive statement of these terms.
