The above-captioned matter having come before the Board upon a Stipulated Settlement Agreement between the Enforcement Division of the Washington State Liquor Control Board and the Licensee, and the Board having reviewed the Stipulated Settlement Agreement:


IT IS HEREBY ORDERED that the Stipulated Settlement Agreement for Case Number 23,507 is approved.

ACCORDINGLY the Licensee shall pay a monetary penalty of five-hundred dollars within thirty days of the issuance of this Final Order. Payment is to be sent to: Washington State Liquor Control Board, Enforcement and Education Division, P.O. Box 43085, Olympia, WA 98504-3085.

In the event the Licensee fails to make full and timely payment of the monetary penalty, the Licensee shall serve a five (5) day suspension of its liquor license from 10:00 am on January 8, 2010 until 10:00 am on January 13, 2010.

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, Jaspar Holdings, Inc., d/b/a Slo Pitch Pub and Eatery (Licensee), represented by JASKARN GILL, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23,507.

**I. INTRODUCTION**

The Washington State Liquor Control Board charged the above-named Licensee in its Complaint dated May 5, 2009, with the following violation of the Washington State Liquor Act:

On or about February 6, 2009, the Licensee and/or employee(s) thereof permitted a person apparently under the influence of liquor to physically possess and or consume liquor on the licensed premise in violation of WAC 314-16-150.

Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced Complaint.

**II. AGREEMENT OF THE PARTIES**

Enforcement and the Licensee agree to the following:

1           1.     Enforcement and the Licensee enter into this agreement to avoid the time and  
2 expense of further litigation. The Licensee explicitly waives the right of further administrative  
3 review of all matters related to this violation. The Licensee hereby voluntarily withdraws its  
4 request for a hearing on the matter.

5           2.     The Licensee admits to the violation set forth in the above-referenced  
6 Complaint. On February 6, 2009, the Licensee and/or employee(s) thereof permitted a person  
7 apparently under the influence of liquor to physically possess liquor on the licensed premises.

8           3.     The parties agree that as a first violation for permitting a person apparently  
9 under the influence of liquor to physically possess and/or consume liquor on the licensed  
10 premises, the standard penalty is a 5-day suspension of the Licensee's liquor license or a  
11 monetary option of \$500.00.

12           5.     The parties agree that the Licensee will pay the monetary penalty of five  
13 hundred dollars (\$500.00) within thirty days of a final order issued by the Board adopting the  
14 settlement agreement in this matter. Payment shall be mailed to:




