THIS MATTER having come before the Washington State Liquor Control Board (“Board”) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and JENNIFER ELIAS, Assistant Attorney General, and the Licensee, WAYNE ENTERTAINMENT, d/b/a QUARTERDECK BAR, represented by LUKE WAYNE, owner, and the parties having voluntarily entered into a stipulated settlement agreement for Administrative Violation Notice (“AVN”) numbers 1L9037A and 1L9064A, case numbers 23,514 and 23,532, and the Board having considered the stipulated settlement agreement and Enforcement’s memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED that AVN number 1L9037A for Case Number 23,514 is converted to a written warning and that AVN number 1L9064A is sustained. Within thirty

1 (30) days of the date of this Order, the Licensee shall pay a monetary penalty of five-hundred
2 dollars (\$500.00) to:

6 In the event that the Licensee fails to timely pay the monetary penalty ordered above, the
7 Licensee shall serve a five (5) day suspension of his liquor license pursuant to the stipulated

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (“Enforcement”) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and JENNIFER ELIAS, Assistant Attorney General, and the Licensee, LUKE WAYNE ENTERTAINMENT, d/b/a QUARTERDECK BAR (“Licensee”) through its representative LUKE WAYNE, owner, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Numbers 23,514 and 23,532.

I. INTRODUCTION

1. The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice (“AVN”) No. 1L9037A on February 17, 2009, to the above-named Licensee specifying the following violation of the Washington State Liquor Act:

On or about February 6, 2009, the above-named Licensee, or an employee(s) thereof, allowed an apparently intoxicated person to possess and/or consume liquor on the licensed premises, in violation of WAC 314-16-150.

1 6. If the Licensee subsequently fails to make a full and timely payment of the
2 penalty as required in Section II, Paragraph 4, then the standard penalty of a five (5) day
3 suspension of the Licensee's liquor license shall be imposed.

4 7. The parties recognize that this settlement agreement is subject to approval by
5 the Washington State Liquor Control Board.

6 8. This agreement constitutes the final written expression of all the terms of this
7 agreement and is a complete and exclusive statement of these terms.
