THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, ZUFAN BESHA OR MANDEFRO LISANWORK d/b/a MESOB RESTAURANT (Licensee) and the parties having voluntarily entered into a stipulated settlement agreement for AVN No. 2D8341A, Case No. 23,515, and the Board having considered the stipulated settlement agreement and Enforcement's memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED that the Stipulated Settlement Agreement for Case No. 23,515 is approved, that AVN No. 2D8341A, Case No. 23,515 are sustained; and the Licensee

1 shall serve a three day suspension of their liquor license beginning at 9:00 a.m.

3 August 28, 2009 and ending at 9:00 a.m. August 31, 2009.

4 FURTHERMORE if the Licensee fails to comply with the three-day suspension of their
5 license, the Licensee shall serve a five (5) day suspension of its liquor license, pursuant to
6 WAC 314-29-025; the dates and time of which shall be set by the Washington State Liquor
7 Control Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, ZUFAN BESHA OR MANDEFRO LISANERWORK d/b/a MESOB RESTAURANT (Licensee) hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23, 515.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division, charged the above-named Licensee, through Administrative Violation Notice (AVN) No. 2D8341A issued on February 2, 2009, with the following violations of the Washington State Liquor Act and Liquor Control Board Rules:

On or about December 6, 2008, the Licensee and/or employee(s) thereof, allowed patrons to possess or consume alcohol between the hours of 2:00 a.m. and 6:00 a.m., on the licensed premise, in violation of WAC 314-11-070(1)(e-f).

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. Enforcement and the Licensee enter into this agreement to avoid the time and
4 expense of further litigation. The Licensee explicitly waives the right of further administrative
5 review of all matters related to the above-referenced Complaint. The Licensee hereby
6 voluntarily withdraws its requests for hearing on the above-referenced Complaint.

7 2. The Licensee admits to the violations set forth in the above-referenced AVN.
8 The Licensee admits that on or about December 6, 2008, the Licensee and/or employee(s)
9 thereof, allowed patrons to possess or consume alcohol sometime between the hours of 2:00
10 a.m. and 6:00 a.m., on the licensed premise, in violation of WAC 314-11-070(1)(e-f).


11 3. The Licensee agrees to serve a three day suspension of their liquor license
12 beginning at 9:00 a.m. August 28, 2009 and ending at 9:00 a.m. August 31, 2009.

13 4. If the Licensee fails to comply with the three day suspension of their license, as
14 required by Section II, Paragraph 3, the Licensee shall serve a five (5) day suspension of its
15 liquor license, pursuant to WAC 314-29-025; the dates and time of which shall be set by the
16 Washington State Liquor Control Board.

17 5. The parties recognize that this settlement agreement is subject to approval by
18 the Washington State Liquor Control Board.
