The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys, ROBERT M. MCKENNA, Attorney General, and GORDON KARG, Assistant Attorney General, and the Licensee, Yourbesthome.com, Inc. d/b/a Sip City Wine (Licensee) represented by DAVID OSGOOD, Attorney at Law, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,519.

I. INTRODUCTION

The Washington State Liquor Control Board charged the above-named Licensee, in Administrative Violation Notice (AVN) No. 2P9059C, with the following violations of the Washington State Liquor Control Board law:

That on or about February 28, 2009, the above-named Licensee, or an employee(s) thereof, sold, served or otherwise supplied liquor to a person under twenty-one (21) years of age, contrary to RCW 66.44.270(1).

STIPULATED SETTLEMENT
AGREEMENT

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced AVN.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation. The Licensee explicitly waives the right of further administrative
7 review of all matters related to the above referenced violation and AVN. The Licensee hereby
8 voluntarily withdraws its request for a hearing in this matter.

9 2. This agreement constitutes the final written expression of all the terms of this
10 agreement and is a complete and exclusive statement of these terms.

11 3. The Licensee admits to the violation set forth in AVN No. 2P9059C: that on or
12 about February 28, 2009, the above-named Licensee, or an employee(s) thereof, sold, served or
13 otherwise supplied liquor to a person under twenty-one (21) years of age, contrary to RCW
14 66.44.270(1).

15 4. The Licensee acknowledges this is the Licensee's first violation of this type
16 within a twenty four month period, which carries a standard monetary penalty of five hundred
17 dollars (\$500) or a five day suspension of the liquor license.

18 5. The Licensee agrees to pay a total monetary penalty of three hundred dollars
19 (\$300) for the above-referenced violation. This amount shall be paid within thirty (30) days of
20 the date of the final order of the Washington State Liquor Control Board. Payment shall be
21 made to the Washington State Liquor Control Board no later than 4:00 p.m. on the applicable
22 date.


23 6. In the event that the Licensee does not make a timely payment, as required by
24 Section II, Paragraph 5, the Licensee shall serve a five (5) day suspension of its liquor license,
25 pursuant to WAC 314-29-020; the dates and times of which shall be set by the Washington
26 State Liquor Control Board.

1 7. The parties recognize that this settlement agreement is subject to approval by
2 the Washington State Liquor Control Board.


