**I. INTRODUCTION**

1. The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 4F9093A (AVN) to the above-named Licensee specifying the following violation of the Washington State Liquor Act:

On or about April 3, 2009, the above-named Licensee sold, gave, or otherwise supplied alcohol to person under twenty-one years of age contrary to RCW 66.44.270(1).
