IT IS HEREBY ORDERED the Board accepts, adopts and incorporates herein by reference the stipulated settlement agreement between Enforcement and the Licensee in the above captioned matter and further that the violation set forth and charged In its Complaint in the above titled matter issued on August 25, 2009 is sustained and the Licensee shall serve four

1 day suspension of its liquor license for the above-referenced violation, beginning at 10:00 a.m.  
2 on April 29, 2010 and ending at 10:00 a.m. on May 3, 2010:

3 FURTHERMORE, in the event the Licensee fails to abide by the agreed upon  
4 suspension, the Licensee shall serve a five (7) day suspension of its liquor license, the dates  
5 and time of which shall be set by the Washington State Liquor Control Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys, ROBERT M. MCKENNA, Attorney General, and GORDON KARG, Assistant Attorney General, and the Licensee, North Bend Gasoline Inc. d/b/a North Bend (Licensee) represented by WAGIH M. ABU-RISH, Corporate Officer, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,546.

**I. INTRODUCTION**

In its Complaint issued on August 25, 2009 The Washington State Liquor Control Board charged the above-named Licensee, with the following violations of the Washington State Liquor Control Board law:

That on or about May 29, 2009, the above-named Licensee, or employee(s) thereof, supplied liquor to a person under twenty-one (21) years of age, for off premises consumption, contrary to RCW 66.44.270(1).

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the  
2 above-referenced Complaint.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
6 expense of further litigation. The Licensee explicitly waives the right of further administrative  
7 review of all matters related to the above referenced violation and Complaint. The Licensee  
8 hereby voluntarily withdraws its request for a hearing in this matter.

9 2. This agreement constitutes the final written expression of all the terms of this  
10 agreement and is a complete and exclusive statement of these terms.

11 3. The Licensee admits to the violation set forth in the above referenced  
12 Complaint: That on or about May 29, 2009, the above-named Licensee, or employee(s)  
13 thereof, supplied liquor to a person under twenty-one (21) years of age, for off premises  
14 consumption, contrary to RCW 66.44.270(1).

15 4. The Licensee acknowledges this is the Licensee's second violation of this type  
16 within a twenty four month period, which carries a standard of a seven (7) day suspension of the  
17 liquor license.

18 5. The Licensee agrees to serve four day suspension of its liquor license for the  
19 above-referenced violation, beginning at 10:00 a.m. on April 29, 2010 and ending at 10:00 a.m.  
20 on May 3, 2010.

21 6. In the event that the Licensee fails to cease all alcohol sales during the  
22 suspension period, as required by Section II, Paragraph 5, the Washington State Liquor Control  
23 Board will assess additional penalties.


7. The parties recognize that this settlement agreement is subject to approval by the Washington State Liquor Control Board.




