THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and GORDON P. KARG, Assistant Attorney General, and the Licensee, MESO LLC d/b/a MURPHY'S PUB (Licensee), represented by Sally Gustafson Garratt, Attorney at Law (Licensee) and the parties having voluntarily entered into a stipulated settlement agreement for AVN No. 2Z9022D, Case No. 23,579, and the Board having considered the stipulated settlement agreement and Enforcement's memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED that the Stipulated Settlement Agreement for Case No. 23,579 is approved and the Licensee shall pay a monetary penalty of one hundred and ninety dollars (\$190) to the Washington State Liquor Control Board within thirty days (30) of the issuance of this final order. The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, MESO LLC d/b/a MURPHY'S PUB (Licensee), represented by Sally Gustafson Garratt, Attorney at Law, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23,579.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division, charged the above-named Licensee, through Administrative Violation Notice (AVN) No. 2Z9022D issued on March 25, 2009, with two violations of the Washington State Liquor Act and/or Liquor Control Board Rules. One of the alleged violations being that:

On or about January 31, 2009, the Licensee and/or employee(s) thereof, allowed patrons to possess or consume alcohol between the hours of 2:00 a.m. and 6:00 a.m., on the licensed premise, in violation of WAC 314-11-070(1)(e-f).

1 II. AGREEMENT OF THE PARTIES

2 Enforcement and the Licensee agree to the following:

3 1. Enforcement and the Licensee enter into this agreement to avoid the time and
4 expense of further litigation. The Licensee explicitly waives the right of further administrative
5 review of all matters related to the above-referenced AVN. The Licensee hereby voluntarily
6 withdraws its requests for hearing on the above-referenced AVN.

7 2. The Licensee admits to the one violation described above in Section I, as set
8 forth in the above-referenced AVN. The Licensee admits that on or about January 31, 2009,
9 the Licensee and/or employee(s) thereof, allowed patrons to possess or consume alcohol
10 between the hours of 2:00 a.m. and 6:00 a.m., on the licensed premise, in violation of WAC
11 314-11-070(1)(e-f).

12 3. The Parties agree this is the Licensee’s first violation of this type in a twenty
13 four month period.

14 4. The parties agree the standard penalty for a violation of this type is a five day
15 suspension of the liquor license or a monetary penalty of two hundred and fifty dollars (\$250)

16 5. The Licensee agrees to pay a one hundred and ninety dollar (\$190) monetary
17 penalty to the Washington State Liquor Control Board within thirty (30) days of the issuance
18 of a final order adopting this agreement. Payment shall be sent to:

22 6. If the Licensee fails to comply with the payment of the monetary penalty, as
23 required by Section II, Paragraph 5, the Licensee shall serve a five (5) day suspension of its
24 liquor license, pursuant to WAC 314-29-025; the dates and time of which shall be set by the
25 Washington State Liquor Control Board.

26 7. Enforcement agrees that upon issuance of the final order adopting this
agreement it will not prosecute and completely dispose of the remaining violation charged in

1 the above referenced AVN's and will withdraw the written warning set out in the above
2 referenced AVN.

3 8. The Parties recognize that this settlement agreement is subject to approval by
4 the Washington State Liquor Control Board.


