3 2L9244A for Case Number 23,580 is sustained.


4 IT IS FURTHER ORDERED that within thirty (30) days of this order, the Licensee

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, SONGLAND, LLC d/b/a CENTER ORIENTAL GROCERY (Licensee) through its representative, YOUNG CHA SONG, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23,580.

I. INTRODUCTION

1. The Washington State Liquor Control Board Education and Enforcement Division issued an Administrative Violation Notice No. 2L9244A (AVN) to the above-named Licensee specifying the following violation of the Washington State Liquor Act:

On or about September 1, 2009, the above-named Licensee, or employee(s) thereof, did sell and/or supply liquor to a person, Patrick K. Epler, who was apparently under the influence of liquor, contrary to RCW 66.44.200 and/or WAC 314-16-150.

1 7. In the event that the Licensee fails to make full and timely payment of the
2 monetary penalty as required in Section II, Paragraph 6, the Licensee shall serve a three (3) day
3 suspension of its liquor license, the dates and time of which shall be set by the Washington
4 State Liquor Control Board.

5 8. The parties recognize that this settlement agreement is subject to approval by
6 the Washington State Liquor Control Board.

7 9. This settlement agreement constitutes the final written expression of all the
8 terms of this agreement and is a complete and exclusive statement of these terms, and shall be
9 effective when signed by all parties and/or their legal representatives.




