MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and APPLE WASHINGTON, LLC d/b/a APPLEBEE'S NEIGHBORHOOD GRILL AND BAR (Licensee) through its representative, DAN KREBSBACH, and the parties having voluntarily entered into a stipulated settlement agreement for LCB No. 23,599, arising from Administrative Violation Notice (AVN) No. 1R9268D, the Board having considered the stipulated settlement agreement and Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

1 IT IS HEREBY ORDERED that the allegation set forth in AVN No. 1R9268D is
2 sustained and the Licensee shall pay a monetary penalty of three hundred dollars (\$300.00) to:

6 In the event the Licensee fails to make full and timely payment of the monetary penalty, the
7 Licensee shall serve a three (3) day suspension of its liquor license, the dates and time of which


1 7. The parties recognize that this settlement agreement is subject to approval by


