15 THIS MATTER having come before the Washington State Liquor Control Board  
16 (Board) and The Washington State Liquor Control Board Education and Enforcement Division  
17 (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and  
18 LISA K. ELLEY, Assistant Attorney General, and the Licensee, SANG HOON LEE and YOU  
19 LEE, d/b/a C AND C FOOD STORE (Licensee), represented by DAVID R. OSGOOD,  
20 Attorney at Law, and the Board having considered the Stipulated Settlement Agreement and  
21 Enforcement's Memorandum recommending acceptance of the settlement agreement, and the  
22 Board having had the opportunity to review the file materials maintained in this case, now  
23 therefore:


24 IT IS HEREBY ORDERED the Board accepts, adopts, and incorporates herein by  
25 reference the Stipulated Settlement Agreement between Enforcement and the Licensee in the  
26 above captioned matter.

1 IT IS FURTHER ORDERED that the Complaint dated January 4, 2010, shall be  
2 dismissed and Administrative Violation Notice (AVN) number 2K9172B shall be converted to  
3 a written warning.

4 IT IS FURTHER ORDERED that the allegation set forth in AVN number 2C0114C is  
5 sustained and the Licensee shall 1) pay a monetary penalty of one thousand five hundred  
6 dollars (\$1,500.00) to the Washington State Liquor Control Board, P. O. Box 43085, Olympia,  
7 WA, 98504-3085; 2) install an ID reader within thirty (30) days of the date of the Final Order  
8 of the Board; and 3) require every employee to successfully complete the Mandatory Alcohol  
9 Server Training (MAST) within sixty (60) days of the date of the Final Order of the Board,  
10 regardless of the current status of the employee's MAST permit. In the event the Licensee  
11 fails to comply with any of the three conditions listed above, the Licensee shall serve a five (5)  
12 day suspension of its liquor license, the dates and time of which shall be set by the Washington  
13 State Liquor Control Board.

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and LISA K. ELLEY, Assistant Attorney General, and the Licensee, SANG HOON LEE and YOU LEE, d/b/a C AND C FOOD STORE (Licensee), represented by DAVID R. OSGOOD, Attorney at Law, hereby enter into this Stipulated Settlement Agreement for Liquor Control Board (LCB) case numbers 23,600 and 23,699, arising from Administrative Violation Notices (AVNs) 2K9172B and 2C0114C.

**I. INTRODUCTION**

1. Liquor Control Board case number 23,600 (AVN number 2K9172B): The Washington State Liquor Control Board charged the above-named Licensee in its Complaint dated January 4, 2010, with the following violation of the Washington State Liquor Act:

On or about June 21, 2009, the above-named Licensee, or an employee(s) thereof, sold, gave and/or otherwise supplied liquor to a person under the age of twenty-one (21), in violation of RCW 66.44.270(1) and WAC 314.11.020.

B. Installation of an ID reader within thirty (30) days of the date of  
the Final Order of the Board; and


C. Every employee shall successfully complete the Mandatory  
Alcohol Server Training (MAST) within sixty (60) days of the  
date of the Final Order of the Board, regardless of the current  
status of each employee's MAST permit.

5. If the Licensee subsequently fails to successfully comply with any of the three  
conditions required in Section II, Paragraph 4, then the standard penalty of a five (5) day  
suspension of the Licensee's liquor license shall be imposed, the dates and time of which shall  
be set by the Washington State Liquor Control Board.

6. The parties recognize that this settlement agreement is subject to approval by  
the Washington State Liquor Control Board.

7. This agreement constitutes the final written expression of all the terms of this  
agreement and is a complete and exclusive statement of these terms.
