THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement), having been represented by its attorneys, ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and B.C.M. MACDONALD TAVERNS, INC d/b/a B.C. MACDONALD LAKESIDE ALE HOUSE of Chehalis, Washington, having been represented by BRENT MACDONALD, and the parties having voluntarily entered into a stipulated settlement agreement for LCB No. 23,605, arising from Administrative Violation Notice (AVN) No. 4H9247B, the Board having considered the stipulated settlement agreement and Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

1 IT IS HEREBY ORDERED that the allegation set forth in AVN No. 4H9247B is
2 sustained and the Licensee shall pay a monetary penalty of three hundred dollars (\$300.00) to:

5 In the event the Licensee fails to make full and timely payment of the monetary penalty, the
6 Licensee shall serve a five (5) day suspension of its liquor license, the dates and time of which


