MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, LA UNION, LLC d/b/a THE RODEO STEAKHOUSE AND SALOON (Licensee) through its representative, CESAR VILLAGOMEZ, and the parties having voluntarily entered into a stipulated settlement agreement for LCB No. 23,612, arising from Administrative Violation Notice (AVN) No. 2M9303B, the Board having considered the stipulated settlement agreement and Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

1 IT IS HEREBY ORDERED that the allegation set forth in AVN No. 2M9303B is  
2 sustained and the Licensee shall pay a monetary penalty of two hundred dollars (\$200.00)

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, LA UNION, LLC d/b/a THE RODEO STEAKHOUSE AND SALOON (Licensee) through its representative, CESAR VILLAGOMEZ, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23,612.

**I. INTRODUCTION**

1. Enforcement issued Administrative Violation Notice No. 2M9303B (AVN) alleging that on or about April 23, 2009, the above-named Licensee (1) failed to maintain kitchen equipment necessary to prepare the required complete meals, failed to have food items and/or edible food items required to maintain the menu, and/or failed to provide required food service, contrary to RCW 66.24.410 and WAC 314-02-035 and (2) had inadequate lighting,

6. In the event that the Licensee fails to make full and timely payment of the monetary penalty as required in Section II, Paragraph 5, the Licensee shall serve a five (5) day suspension of its liquor license, the dates and time of which shall be set by the Washington State Liquor Control Board.

7. The parties recognize that this settlement agreement is subject to approval by the Washington State Liquor Control Board.

8. This settlement agreement constitutes the final written expression of all the terms of this agreement and is a complete and exclusive statement of these terms, and shall be effective when signed by all parties and/or their legal representatives.


