FINAL ORDER OF THE BOARD

[PROPOSED]

THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement), having been represented by its attorneys, ROBERT M. MCKENNA, Attorney General and LISA K. ELLEY, Assistant Attorney General, and BUBBA'S ROADHOUSE, INC d/b/a BUBBA'S ROADHOUSE of Sultan, Washington, having been represented by DUANE DEACH, and the parties having voluntarily entered into a stipulated settlement agreement for LCB No. 23,620, arising from Administrative Violation Notice (AVN) No. 3S9345B, the Board having considered the stipulated settlement agreement and Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

1 IT IS HEREBY ORDERED that the allegation set forth in AVN No. 3S9345B is  
2 sustained and the Licensee shall pay a monetary penalty of three hundred dollars (\$300.00) to:

ELLEY, Assistant Attorney General and BUBBA'S ROADHOUSE, INC d/b/a BUBBA'S ROADHOUSE of Sultan, Washington, by and through its representative, DUANE DEACH, hereby enter into this stipulated settlement agreement for Liquor Control Board (LCB) case number 23,620, arising from Administrative Violation Notice (AVN) No. 3S9345B.

**I. INTRODUCTION**

1. The Washington State Liquor Control Board Enforcement Division issued to the Licensee AVN No. 3S9345B alleging that on or about December 12, 2009, the above-named Licensee, or an employee(s) thereof, allowed a person apparently under the influence of liquor to possess and/or consume liquor on the licensed premises, contrary to WAC 314-16-150.




1           6.     In the event that the Licensee fails to make full and timely payment of the  
2 monetary penalty as required in Section II, Paragraph 5, the Licensee shall serve a five (5) day  
3 suspension of its liquor license, the dates and time of which shall be set by the Washington


