
16 THIS MATTER having come before the Washington State Liquor Control Board

21 representative, WILLIAM SCHECK, and the parties having voluntarily entered into a
22 stipulated settlement agreement for Liquor Control Board No. 23,636, arising from
23 Administrative Violation Notice (AVN) No. 3G0008A, and the Board having considered the
24 stipulated settlement agreement and Enforcement's Memorandum recommending acceptance
25 of the stipulated settlement agreement, and the Board having had the opportunity to review the
26 file materials maintained in this case, now therefore:

1 IT IS HEREBY ORDERED that the violation set forth in Administrative Violation
2 Notice No. 3G0008A is sustained.

3 It is FURTHER ORDERED that there shall be no assessment of fees or suspension
4 associated with this violation, as the licensee has sold the business.

I. INTRODUCTION




