22 Agreement for Liquor Control Board No. 23,640, arising from Administrative Violation Notice

24 and Enforcement's Memorandum recommending acceptance of the Stipulated Settlement  
25 Agreement, and the Board having had the opportunity to review the file materials maintained

1 IT IS HEREBY ORDERED that the violation set forth in Administrative Violation  
2 Notice No. 4K9352A is sustained.

3 It is FURTHER ORDERED that there shall be no assessment of fees or suspension  
4 associated with this violation, as the licensee has discontinued its business.

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, JYM STARR, LLC d/b/a THE GAME BAR AND GRILL (Licensee) of Yakima, Washington, through its attorney, ETOY ALFORD, JR., hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23,640.

**I. INTRODUCTION**

1. Enforcement issued Administrative Violation Notice No. 4K9352A (AVN) alleging that on or about December 18, 2009, the Licensee or an employee thereof, consumed liquor while working on the licensed premises, contrary to WAC 314-11-015(3)(d).

2. Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced AVN.

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to the issuance of a Complaint, Enforcement and the Licensee agree to the  
3 following:

4 1. The parties enter into this agreement to avoid the time and expense of further  
5 litigation.

6 2. The Licensee explicitly waives the right of further administrative review of all  
7 matters related to the above-referenced case and AVN. Furthermore, the Licensee hereby  
8 voluntarily withdraws its request for a hearing in this matter.

9 3. The Licensee admits to the violation set forth in AVN No. 4K9352A.  
10 Specifically, on or about December 18, 2009, the Licensee, or an employee thereof, consumed  
11 liquor while working on the licensed premises.

12 4. The Licensee admits that the Game Bar and Grill has discontinued its business.

13 5. The parties agree that the standard penalty for a second violation for the  
14 Licensee, or an employee thereof, consuming liquor while working on the licensed premises is  
15 a seven (7) day suspension. However, the parties agree that the penalty is no longer a viable  
16 option, as the licensee has discontinued its business. The parties therefore agree that there will  
17 be no assessment of any fees or suspension associated with this violation.

18 6. The parties recognize that this settlement agreement is subject to approval by  
19 the Washington State Liquor Control Board.




