STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, SONJA KIFER, d/b/a. SEVEN STAR MARKET (Licensee), hereby enter into this stipulated settlement agreement for LCB Case No. 23,646.

I. INTRODUCTION

The Washington State Liquor Control Board issued a complaint on May 12, 2010, alleging that on or about February 12, 2010, the above-named Licensee, or employee(s) thereof, supplied liquor to a person(s) under twenty-one (21) years of age, for off premises consumption, contrary to RCW 66.44.270(1).

II. AGREEMENT OF THE PARTIES

Prior to the scheduled administrative hearing in this matter, Enforcement and the Licensee have agreed to enter into the following stipulated settlement agreement concerning the above-referenced case. Enforcement and the Licensee agree to the following:

ORIGINAL

1 1. Enforcement and the Licensee enter into this agreement to avoid the time and
2 expense of further litigation.

3 2. The Licensee explicitly waives the right of further administrative review of all
4 matters related to the above-referenced case. Furthermore, the Licensee hereby voluntarily
5 withdraws its request for a hearing on this matter.

6 3. This Agreement constitutes the final written expression of all the terms of this
7 agreement and is a complete and exclusive statement of these terms.

8 4. The Licensee admits to the violation set forth in the above-referenced case.
9 Specifically, that on or about February 12, 2010, the above-named Licensee, or employee(s)
10 thereof, supplied liquor to a person(s) under twenty-one (21) years of age, for off premises
11 consumption, contrary to RCW 66:44.270(1).

12 5. The Licensee acknowledges this is the Licensee's second violation of this type
13 within a twenty four month period, which carries a standard penalty of a seven (7) day suspension
14 of the suspension of the liquor license.

15 7. The Licensee agrees to serve a five day (5) suspension of its liquor license
16 beginning December 1, 2010 at 10:00 a.m. and concluding on December 6, 2010 at 10:00 a.m.

17 8. In the event that the Licensee does not serve the entirety of its suspension, as
18 required by Section II, Paragraph 7, the Licensee shall be subject to further penalties to be
19 determined by the Washington State Liquor Control Board.

20 9. The undersigned parties declare that the terms of this Settlement Agreement are
21 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
22 and final compromise and settlement of any and all claims arising from the above referenced
23 Complaint.

24 10. The parties recognize that this settlement agreement is subject to approval by
25 the WASHINGTON STATE LIQUOR CONTROL BOARD.


