2 restriction is imposed due to Vladislav Dadyan's criminal history.

**I. INTRODUCTION**

On April 27, 2010, Licensing issued a Statement of Intent to Deny the Applicant's Liquor License Application No. 405763. The application was denied for failure to disclose information pursuant to WAC 314-07-065(3), WAC 314-07-065 (6), WAC 314-12-010, and criminal history of a governing person, Vladislav Dadyan, pursuant to RCW 66.24.010(2), WAC 314-07-040, WAC 314-07-065(4). On April 29, 2010, the Applicant filed a timely request for a formal administrative hearing to appeal Licensing's decision because it did not


