The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and TIMOTHY D. FORD, Assistant Attorney General and the Licensee, JUNG SOOK JUNG d/b/a PEARL DELI & GROCERY represented by JUNG S. JUNG, Owner/Manager, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,671.

**I. INTRODUCTION**

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee, in Administrative Violation Notice (AVN) No. 1U0050A, with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

1 That on or about February 19, 2010, the above-named Licensee, or employee(s)  
2 thereof, sold, gave or otherwise supplied liquor to a person(s) under twenty-one (21) years of  
3 age, in violation of RCW 66.44.270 and WAC 314-11-020(1).

4 Enforcement and the Licensee wish to enter into a settlement agreement concerning the  
5 above-referenced AVN.

## 6 II. AGREEMENT OF THE PARTIES

7 Enforcement and the Licensee agree to the following:

8 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
9 expense of further litigation. The Licensee explicitly waives the right of further administrative  
10 review of all matters related to the above-referenced violation and AVN. The Licensee hereby  
11 voluntarily withdraws its requests for a hearing in this matter.

12 2. This agreement constitutes the final written expression of all the terms of this  
13 agreement and is a complete and exclusive statement of these terms.

14 3. The Licensee admits the violation set forth above and referenced in the  
15 complaint: that on or about February 19, 2010, the above-named Licensee, or employee(s)  
16 thereof, sold, gave or otherwise supplied liquor to a person(s) under twenty-one (21) years of  
17 age, in violation of RCW 66.44.270 and WAC 314-11-020(1).

18 4. The Licensee acknowledges this is the Licensee's third violation of this type  
19 within a twenty-four (24) month period, which carries a standard penalty of a thirty (30) day  
20 suspension of the liquor license.

21 5. The Licensee agrees to a twenty (20) day suspension for the above-referenced  
22 violation, and to complete additional training to be provided by the Liquor Control Board.

23 6. The undersigned parties declare that the terms of this Settlement Agreement are  
24 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
25 and final compromise and settlement of any and all claims arising from the above referenced  
26 Complaint.


