

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General and the Licensee, EL CLUB, INC., d/b/a EL PARRAL (Licensee) by and through their counsel LARRY E. HAZEN, Attorney at Law, hereby enter into this Stipulated Settlement Agreement for LCB Case No. 23,715.

**I. INTRODUCTION**

The Washington State Liquor Control Board Enforcement and Education Division issued Administrative Violation Notice (AVN) No. 1L0135A alleging that on May 15, 2010, the above-named Licensee, or employee(s) thereof, allowed a person(s) under twenty-one (21) years of age, to enter and remain in a portion of the licensed premise designated as off-limits to persons less than twenty-one (21) years of age, contrary to RCW 66.44.310(1)(a).

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to scheduling an administrative hearing in this matter, Enforcement and the  
3 Licensee have agreed to enter into the following Stipulated Settlement Agreement concerning  
4 the above-referenced case. Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and  
6 expense of further litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all  
8 matters related to the above-referenced case. Furthermore, the Licensee hereby voluntarily  
9 withdraws its request for a hearing on this matter.

10 3. This Agreement constitutes the final written expression of all the terms of this  
11 agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee admits to the violation set forth in the above-referenced AVN No.  
13 1L0135A. Specifically, that on or about May 15, 2010, the above-named Licensee, or  
14 employee(s) thereof, allowed a person(s) under twenty-one (21) years of age, to enter and  
15 remain in a portion of the licensed premise designated as off-limits to persons less than twenty-  
16 one (21) years of age, contrary to RCW 66.44.310(1)(a).

17 5. The Licensee acknowledges this is the Licensee's first violation of this type  
18 within a twenty-four (24) month period, which carries a standard penalty of a five (5) day  
19 suspension of the of the liquor license or a five hundred dollar (\$500) monetary penalty.

20 6. The Licensee agrees to pay a total monetary penalty of three hundred dollars  
21 (\$300) for the above-referenced AVN No. 1L0135A. This amount shall be paid within thirty  
22 (30) days of the date of the Final Order of the Washington State Liquor Control Board.  
23 Payment shall be made to the Washington State Liquor Control Board no later than 4:00 p.m.  
24 on the applicable date. Payments shall be sent to:

1           7.     In the event that the Licensee does pay the agreed upon monetary penalty, as  
2 required by Section II, Paragraph 6, the Licensee shall be subject to further penalties to be  
3 determined by the Washington State Liquor Control Board.

4           8.     The undersigned parties declare that the terms of this Settlement Agreement are  
5 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
6 and final compromise and settlement of any and all claims arising from the above-referenced  
7 AVN No. 1L0135A.

8           9.     The parties recognize that this Settlement Agreement is subject to approval by  
9 the WASHINGTON STATE LIQUOR CONTROL BOARD.




