THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys, ROBERT M. MCKENNA, Attorney General, and TIMOTHY D. FORD, Assistant Attorney General, and the Licensee, MESFIN, LLC d/b/a SEASHORE MINI MART, and the Board having considered the Stipulated Settlement Agreement and Enforcement's memorandum recommending acceptance of the settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED the Board accepts, adopts and incorporates herein by reference the Stipulated Settlement Agreement between Enforcement and the Licensee in the above-captioned matter and further that the Administrative Violation Notice (AVN) issued by the Enforcement in the above-captioned matter is sustained and the Licensee shall pay a total

1 monetary penalty of four hundred dollars (\$400) for the above-referenced violation and to
2 complete additional training to be provided by the Liquor Control Board. The Licensee shall
3 pay the monetary penalty within thirty (30) days of the date of the Final Order of the Board.



STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and TIMOTHY D. FORD, Assistant Attorney General, and the Licensee, MESFIN, LLC d/b/a SEASHORE MINI MART represented by Tenagne Mesfin, Manager, hereby enter into this Stipulated Settlement Agreement for Liquor Control Board Case No. 23,727.

I. INTRODUCTION

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee, in Administrative Violation Notice (AVN) No. 2Y0162B, with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

That on or about June 11, 2010, the above-named Licensee, or employee(s) thereof, sold, gave or otherwise supplied liquor to a person(s) under twenty-one (21) years of age, in violation of RCW 66.44.270 and WAC 314-11-020(1).

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the
2 above-referenced AVN.

3 **II. AGREEMENT OF THE PARTIES**

4 Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation. The Licensee explicitly waives the right of further administrative
7 review of all matters related to the above-referenced violation and AVN. The Licensee hereby
8 voluntarily withdraws its requests for a hearing in this matter.

9 2. This agreement constitutes the final written expression of all the terms of this
10 agreement and is a complete and exclusive statement of these terms.

11 3. The Licensee admits the violation set forth above and referenced in the
12 complaint: that on or about June 11, 2010, the above-named Licensee, or employee(s) thereof,
13 sold, gave or otherwise supplied liquor to a person(s) under twenty-one (21) years of age, in
14 violation of RCW 66.44.270 and WAC 314-11-020(1).

15 4. The Licensee acknowledges this is the Licensee's first violation of this type
16 within a twenty-four (24) month period, which carries a standard penalty of a five (5) day
17 suspension of the liquor license, or five hundred dollar (\$500) monetary penalty.


18 5. The Licensee agrees to a four hundred dollar (\$400) monetary penalty for the
19 above-referenced violation, and to complete additional training to be provided by the Liquor
20 Control Board.

21 6. The undersigned parties declare that the terms of this Settlement Agreement are
22 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
23 and final compromise and settlement of any and all claims arising from the above referenced
24 Complaint.


1 7. The parties recognize that this settlement agreement is subject to approval by


