CONSIDINE, Assistant Attorney General, and the Licensee, EDDIE'S TRACKSIDE BAR AND GRILL, LLC d/b/a EDDIE'S TRACKSIDE BAR AND GRILL of Monroe, Washington, represented by STEVEN CONTOS, attorney for Licensee, and the parties having voluntarily entered into a stipulated settlement agreement for AVN Number 3F0163A, Case Number 23,730, and the Board having considered the stipulated settlement agreement and Enforcement's memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

1 IT IS HEREBY ORDERED that the violations of allowing an apparently intoxicated
2 person to possess and/or consume liquor on the licensed premises, contrary to WAC 314-16-
3 150, in above-referenced Complaint and case number is sustained.

4 IT IS FURTHER ORDERED that the Licensee shall serve a fourteen (14) day
5 suspension of its liquor license, effective June 17, 2011, at 10:00 a.m. through July 1, 2011, at
6 10:00 a.m.

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board (Board) Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General, and BRIAN J. CONSIDINE, Assistant Attorney General, and the Licensee, EDDIE'S TRACKSIDE BAR AND GRILL, LLC d/b/a EDDIE'S TRACKSIDE BAR AND GRILL of Monroe, Washington, represented by STEVEN CONTOS, attorney for Licensee, hereby enter into this stipulated settlement agreement for Liquor Control Board Case Number 23,730.

I. INTRODUCTION

1. On September 23, 2010, the Liquor Control Board issued an administrative complaint alleging that on or about June 12, 2010, the above-named Licensee or employee thereof, allowed an apparently intoxicated person to possess and/or consume liquor on the licensed premises, contrary to WAC 314-16-150.

7. The parties recognize that this settlement agreement is subject to approval by the Washington State Liquor Control Board.
