
IT IS HEREBY ORDERED that the allegation set forth in AVN No. 6S0251A is sustained and the Licensee shall pay a monetary penalty of three hundred dollars (\$300) to:

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Licensee, SONA, INC. d/b/a PALACE ON 8TH (Licensee) through its representative JAE SO, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,752, AVN No. 6S0251A.

I. INTRODUCTION

1. Prior to issuance of a complaint, Enforcement alleges that on or about September 9, 2010, the above-named Licensee received moneys or moneys' worth under an agreement or by means of any other business practice or arrangement, contrary to RCW 66.28.305.

2. Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced AVN.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. The parties enter into this agreement to avoid the time and expense of further
4 litigation.

5 2. The Licensee explicitly waives the right of further administrative review of all
6 matters related to the above-referenced violation and AVN. The Licensee hereby voluntarily
7 withdraws its request for a hearing in this matter.

8 3. The Licensee admits to the violation set forth in AVN No. 6S0251A.
9 Specifically, it admits that on or about September 9, 2010, the above-named Licensee received
10 moneys or moneys' worth under an agreement or by means of any other business practice or
11 arrangement.

12 4. The parties agree that this is the Licensee's first violation of this kind within a
13 twenty-four month period, and it carries with it a standard penalty of a three (3) day suspension
14 of the Licensee's liquor license or a monetary penalty of five hundred dollars (\$500).

15 5. The parties agree that the Licensee will pay a monetary penalty of three hundred
16 dollars (\$300) within 30 days of the date of the Final Order of the Board. Payment shall be

21 6. In the event that the Licensee fails to make full and timely payment of the
22 monetary penalty as required in Section II, Paragraph 5, the Licensee shall serve a three (3) day
23 suspension of its liquor license, the dates and time of which shall be set by the Washington
24 State Liquor Control Board.

25 7. This agreement constitutes the final written expression of all the terms of this
26 agreement and is a complete and exclusive statement of these terms.


