AMENDED FINAL ORDER OF
THE BOARD

The above-entitled matter coming on regularly before the Board, and it appearing that:

1. The Enforcement Division of the Liquor Control Board issued an Administrative Violation Notice alleging that on August 28, 2010, the above-named licensee, or an employee thereof, allowed a person under twenty-one (21) years of age to enter and remain in an area classified as off-limits to persons under the age of twenty-one (21), contrary to RCW 66.44.310 and WAC 314-11-020(2).
2. The licensee requested an
3. The parties entered into a settlement agreement, which proposed that the licensee would pay a \$2000.00 monetary penalty in four installments by April 29, 2011.
4. The Liquor Control Board issued a Final Order of the Board on December 14, 2010 supporting the settlement agreement between the Licensee and Enforcement Division.
5. On January 12, 2011, the parties contacted the Board to seek an extra month for the licensee to make the scheduled payments. The Board agreed to the request, allowing an additional month for the licensee to make the scheduled payments.


6. On May 2, 2011, the parties again contacted the Board in order to seek additional time for the licensee to make the payments. The Board declines this request to allow additional time past May 31, 2011 for the licensee to pay in full the stipulated monetary penalty.


NOW THEREFORE;


IT IS HEREBY ORDERED that the stipulated monetary penalty of \$2,000.00 is due by May 31, 2011. If full payment is not received timely, then a seven (7) day suspension shall take place from 10:00 a.m. on June 17, 2011 until 10:00 am on June 24, 2011. Failure to comply with the terms of this order will result in further disciplinary action.


