THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) having been represented by its attorneys, ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Licensee, GOLDEN WEST SALOON, INC. d/b/a GOLDEN WEST RESTAURANT AND LOUNGE (Licensee) through its attorney, KEVIN MCCAMMENT, and the parties having voluntarily entered into a stipulated settlement agreement for Liquor Control Board Case No. 22,781 (AVN No. 1S0267A), and the Board having considered the stipulated settlement agreement and Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:


IT IS HEREBY ORDERED that the allegation set forth in AVN No. 1S0267A is sustained and the Licensee shall pay a monetary penalty of two hundred and fifty dollars

1 (\$250). The Licensee can pay the monetary penalty in two installments of one hundred and  
2 twenty-five dollars (\$125). The first payment of one hundred and twenty-five dollars (\$125) is  
3 due within 30 days from the date of the Final Order of the Board and the second payment is  
4 due within 60 days from the date of the Final Order of the Board. Payment shall be sent to:

8 In the event the Licensee fails to make full and timely payment of the monetary  
9 penalty, the Licensee shall serve a five (5) day suspension of its liquor license, the dates and

STIPULATED SETTLEMENT  
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Licensee, GOLDEN WEST SALOON, INC. d/b/a GOLDEN WEST RESTAURANT AND LOUNGE (Licensee) through its attorney, KEVIN MCCAMENT, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,781.

**I. INTRODUCTION**

1. On September 29, 2010, Enforcement issued Administrative Violation Notice (AVN) No. 1S0267A, alleging that on or about September 25, 2010, the above-named Licensee or employee(s) thereof, sold/served liquor to an apparently intoxicated person on the licensed premises, contrary to RCW 66.44.200 and/or WAC 314-16-150.







