

STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Licensee, Carniceria Las Mas Barata, Inc. d/b/a Carniceria Las Mas Barata (Licensee) through its representative JOEL OROZCO, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,802, AVN NO. 4K0267B.

I. INTRODUCTION

1. On or about September 24, 2010, the Licensee or an employee thereof, sold, gave, or otherwise supplied liquor to a person under the age of twenty-one years, contrary to RCW 66.44.270.

2. Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced AVN.

II. AGREEMENT OF THE PARTIES

Prior to the issuance of a Complaint, Enforcement and the Licensee agree to the following:

1. The parties enter into this agreement to avoid the time and expense of further litigation.

2. The Licensee explicitly waives the right of further administrative review of all matters related to the above-referenced violation and AVN. The Licensee hereby voluntarily withdraws its request for a hearing in this matter.

3. The Licensee admits to the violations set forth in AVN No. 4K0267B. Specifically, it admits that on or about September 24, 2010, the Licensee or an employee thereof, sold, gave, or otherwise supplied liquor to a person under the age of twenty-one years.

4. The parties agree that this is the Licensee's first violation of this kind within a two-year period, and it carries with it a standard penalty of a five (5) day suspension of the Licensee's liquor license or a monetary penalty of five hundred dollars (\$500).

5. The parties agree that the Licensee will pay a monetary penalty of three hundred dollars (\$300) within 30 days of the date of the Final Order of the Board. Payment shall be sent to:

6. In the event that the Licensee fails to make full and timely payment of the monetary penalty as required in Section II, Paragraph 5, the Licensee shall serve a five (5) day suspension of its liquor license, the dates and time of which shall be set by the Washington State Liquor Control Board.

7. This agreement constitutes the final written expression of all the terms of this agreement and is a complete and exclusive statement of these terms.


