FINAL ORDER OF THE BOARD

The above-captioned matter coming on regularly before the Board, and it appearing that:


1. On or about September 24, 2010, the Licensee or an employee thereof, sold, gave, or otherwise supplied liquor to a person under the age of twenty-one years, contrary to RCW 66.44.270.
2. The parties into a settlement agreement regarding the above-referenced AVN.
3. On May 24, 2011, Enforcement and Education Chief Pat Wilson Parmer accepted the terms of the settlement agreement and signed an order setting the penalty at \$300 and setting the dates of a five day suspension to be served if the penalty was not paid.
4. On May 30, 2011, the Board served the order accepting the settlement agreement and imposing a suspension to be served from July 15 to July 20, 2011 if no monetary penalty was paid by June 30, 2011.
5. The Licensee did not make payment of the \$300 monetary penalty on or before June 30, 2011, but no suspension of the liquor license has yet been imposed on the Licensee.

6. On August 15, 2011, the Board's staff received a request from Captain Sheri Lopez to re-schedule the suspension dates due to the fact that no monetary penalty was received and the scheduled suspension dates were not enforced.

Therefore, the Board hereby ORDERS that the Licensee's five (5) day suspension is re-scheduled to take place from 10:00 a.m. on August 26, 2011 until 10:00 a.m. on August 31, 2011.


