THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) having been represented by its attorneys, ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Mandatory Alcohol Server Training (MAST) Permit Holder, MARIBETH LARIVIERE (Permit Holder), and the parties having voluntarily entered into a stipulated settlement agreement for Liquor Control Board Case No. 23,813 (AVN No. 3D0351B), and the Board having considered the stipulated settlement agreement and Enforcement's Memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore

IT IS HEREBY ORDERED that the allegation set forth in AVN No. 3D0351B is sustained and the Permit Holder shall pay a monetary penalty of fifty dollars (\$50) within thirty (30) days of the date of this Final Order. Payment shall be sent to:



5 In the event the Permit Holder fails to make full and timely payment of the monetary penalty,  
6 the Permit Holder shall serve a three (3) day suspension of her MAST Permit, the dates and  
7 time of which shall be set by the Washington State Liquor Control Board.

8 IT IS FURTHER ORDERED that the Permit Holder will participate in a responsible  
9 liquor sales class provided by Enforcement, no later than 60 days after the date of the Final  
10 Order of the Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and BRIAN J. CONSIDINE, Assistant Attorney General and the Mandatory Alcohol Server Training (MAST) Permit Holder, MARIBETH LARIVIERE (Permit Holder), hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,813, AVN No. 3D0351B.

**I. INTRODUCTION**

1. Prior to issuance of a complaint, Enforcement alleges that on or about December 17, 2010, the above-named Permit Holder sold liquor to a person apparently under the influence of liquor, contrary to RCW 66.44.200.

2. Enforcement and the Permit Holder wish to enter into a settlement agreement concerning the above-referenced AVN.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Permit Holder agree to the following:

3 1. The parties enter into this agreement to avoid the time and expense of further  
4 litigation.

5 2. The Permit Holder explicitly waives the right of further administrative review  
6 of all matters related to the above-referenced violation and AVN. The Permit Holder hereby  
7 voluntarily withdraws its request for a hearing in this matter.

8 3. The Permit Holder admits to the violation set forth in AVN No. 3D0351B.  
9 Specifically, she admits that on or about December 17, 2010, she served liquor to a person  
10 apparently under the influence of liquor.

11 4. The parties agree that this is the Permit Holder's first violation of this type  
12 within a twenty-four (24) month period, which carries a standard penalty of a five (5) day  
13 suspension of the Permit Holder's MAST Permit or a monetary penalty of one hundred dollars  
14 (\$100).

15 5. The parties agree that the Permit Holder will pay a monetary penalty of fifty  
16 dollars (\$50) within 30 days of the date of the Final Order of the Board. Payment shall be sent


20 6. In the event that the Permit Holder fails to make full and timely payment of the  
21 monetary penalty as required in Section II, Paragraph 5, the Permit Holder shall serve a three  
22 (3) day suspension of her MAST Permit, the dates and time of which shall be set by the  
23 Washington State Liquor Control Board.

24 7. The Permit Holder further agrees that she will participate in a responsible liquor  
25 sales class provided by Enforcement, no later than 90 days after the date of the Final Order of  
26 the Board.


1           8.     This agreement constitutes the final written expression of all the terms of this  
2 agreement and is a complete and exclusive statement of these terms.

3           9.     The parties recognize that this settlement agreement is subject to approval by  
4 the Washington State Liquor Control Board.


