THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys, ROBERT M. MCKENNA, Attorney General, and TIMOTHY D. FORD, Assistant Attorney General, and the Licensees, YEON SUK CHIE & GWANG AE CHIE, d/b/a HANDY DELI GROCERY represented by their attorney DEOLA LEBRON, and the Board having considered the Stipulated Settlement Agreement and Enforcement's memorandum recommending acceptance of the Settlement Agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED the Board accepts, adopts, and incorporates herein by reference the Stipulated Settlement Agreement between Enforcement and the Licensee in the above-captioned matter and further that the violation set forth in the Complaint dated April 25, 2011 is sustained and the Licensee shall serve a four (4) day suspension of its License

1 No. 369810-1E. The suspension period shall commence **Friday, June 24, 2011 through and**  
2 **including Monday, June 27, 2011** for a total period of 96 consecutive hours. In the event the  
3 Licensee fails to comply with the suspension period set forth herein, the Licensee shall serve a  
4 seven (7) day suspension of its liquor license, the dates and time of which shall be set by the  
5 Washington State Liquor Control Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) represented by its attorneys ROBERT M. MCKENNA, Attorney General and TIMOTHY D. FORD, Assistant Attorney General and the Licensees, YEON SUK CHIE & GWANG AE CHIE, d/b/a HANDY DELI GROCERY, represented by attorney DEOLA LEBRON, hereby enter into this stipulated settlement agreement for Liquor Control Board Case No. 23,827.

**I. INTRODUCTION**

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensees, in Administrative Violation Notice (AVN) No. 1S1035A and Complaint dated April 25, 2011, with the following alleged violation of the Washington State Liquor Control Board rules and regulations:

1 On or about February 4, 2011, the above-named Licensees, or employee(s) thereof,  
2 gave, sold and/or supplied liquor to a person(s) under the age of twenty-one (21), in violation  
3 of RCW 66.44.270 and WAC 314-11-020(1).

4 Enforcement and the Licensees wish to enter into a settlement agreement concerning  
5 the above-referenced AVN.

## 6 II. AGREEMENT OF THE PARTIES

7 Enforcement and the Licensees agree to the following:

8 1. Enforcement and the Licensees enter into this agreement to avoid the time and  
9 expense of further litigation. The Licensees explicitly waive the right of further administrative  
10 review of all matters related to the above-referenced violation and AVN. The Licensees  
11 hereby voluntarily withdraw their request for a hearing in this matter.

12 2. This agreement constitutes the final written expression of all the terms of this  
13 agreement and is a complete and exclusive statement of these terms.

14 3. The Licensees admit the violation set forth above and referenced in the  
15 Complaint: that on or about February 4, 2011, the above-named Licensees, or employee(s)  
16 thereof, sold, gave or otherwise supplied liquor to a person(s) under twenty-one (21) years of  
17 age, in violation of RCW 66.44.270 and WAC 314-11-020.

18 4. The Licensees acknowledge this is the Licensees' second violation of this type  
19 within a twenty-four (24) month period, which carries a standard penalty of a seven (7) day  
20 suspension.

21 5. The Licensees agree to serve a reduced suspension of four (4) consecutive days  
22 in return for stipulating to the violation and waiving the right of an administrative hearing. The  
23 suspension shall be served **starting June 24<sup>th</sup>, 2011 through and including June 27<sup>th</sup>, 2011**  
24 for a total period of 96 consecutive hours.

25 6. In the event that the Licensees do not comply with the suspension period as set  
26 forth in this agreement, the Licensees shall serve a seven (7) day suspension, pursuant to

1 WAC 314-29-020; the dates and times of which shall be set by the Washington State Liquor  
2 Control Board.

3 7. The undersigned parties declare that the terms of this Settlement Agreement are  
4 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
5 and final compromise and settlement of any and all claims arising from the above referenced  
6 Complaint.

7 8. The parties recognize that this settlement agreement is subject to approval by  
8 the Washington State Liquor Control Board.






