1 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement for Case No.
2 23,859 is approved and adopted in its entirety by this order; that the violation charged in the
3 Complaint of August 30, 2011, is sustained, and the Licensee shall pay a total monetary
4 penalty of three hundred dollars (\$300.00) for the above-referenced Complaint. The monetary
5 penalty shall be paid within thirty (30) days of the date of the Final Order of the Washington
6 State Liquor Control Board. In the event that the Licensee fails to timely pay the monetary
7 penalty the Licensee shall be subject to a five (5) day suspension of its liquor license, the dates
8 of suspension to be determined by the Washington State Liquor Control Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General and GORDON KARG, Assistant Attorney General, and the Licensee, HOTRODS BAR & GRILL A PARTNERSHIP, d/b/a HOTRODS BAR & GRILL (Licensee) hereby enter into this Stipulated Settlement Agreement for LCB Case No. 23,859.

I. INTRODUCTION

On August 30, 2011, the Washington State Liquor Control Board issued a complaint alleging That on or about May 8, 2011, the above-named Licensee, or an employee(s) thereof, permitted a person(s) apparently under the influence of liquor to physically possess and/or consume liquor on the licensed premise in violation of WAC 314-16-150(2).

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee have agreed to enter into the following Stipulated
3 Settlement Agreement concerning the above-referenced case. Enforcement and the Licensee
4 agree to the following:

5 1. Enforcement and the Licensee enter into this agreement to avoid the time and
6 expense of further litigation.

7 2. The Licensee explicitly waives the right of further administrative review of all
8 matters related to the above-referenced case. Furthermore, the Licensee hereby voluntarily
9 withdraws its request for a hearing on this matter.

10 3. This Agreement constitutes the final written expression of all the terms of this
11 agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee disputes the truth of the allegations contained in the above-
13 referenced Complaint. However, in order to take advantage of Enforcement's offer of
14 settlement, to avoid legal expenses attendant with further proceedings, and in recognition of
15 the fact that if this matter were to proceed to a hearing there is a risk to the Licensee that an
16 administrative proceeding would result in the conclusion that: on or about May 8, 2011, the
17 above-named Licensee, or an employee(s) thereof, permitted a person(s) apparently under the
18 influence of liquor to physically possess and/or consume liquor on the licensed premise in
19 violation of WAC 314-16-150(2). Therefore, the Licensee agrees to stipulate to the violation
20 set forth in the above-referenced Complaint, solely to take advantage of Enforcement's offer of
21 settlement.

22 5. The parties agree that the Washington State Liquor Control Board will consider
23 that the violations set forth in the above referenced Complaint, as specified at Part I and Part II,
24 ¶4, have been sustained.

2 10. The parties recognize that this Settlement Agreement is subject to approval by
3 the WASHINGTON STATE LIQUOR CONTROL BOARD.


