IT IS HEREBY ORDERED that the AVN for Case Number 23,862 is sustained and the Licensee shall pay a monetary penalty of three hundred dollar (\$300) to be paid within thirty

25 May 20, 2011, the above-named Licensee, or an employee thereof, sold, allowed, and/or  
26 permitted an apparently intoxicated person(s) to consume liquor and/or possess liquor on the  
licensed premises, contrary to WAC 314-16-150.




