1 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement for Case No.  
2 23,876 is approved and adopted in its entirety by this order; that the violation charged in the  
3 Amended Administrative Violation Notice (AVN) No. 6C1213B, is sustained, and the  
4 Licensee shall be subject to a two (2) day suspension of their liquor license for the above-  
5 referenced AVN to take place from 12:00 p.m. Tuesday, April 3, 2012 to 12:00 p.m.  
6 Thursday, April 5, 2012. In the event that the Licensee operates under its liquor license  
7 during its suspension, the Licensee shall be subject to a further (3) day suspension of its  
8 license, the dates of suspension to be determined by the Washington State Liquor Control  
9 Board.

**I. INTRODUCTION**

The Washington State Liquor Control Board, Enforcement and Education Division charged the above-named Licensee, in Amended Administrative Violation Notice (AVN) No. 6C1213B, with the following alleged violation of the Washington State Liquor Act:

That on or about July 1, 2011, the above-named Licensee or employee(s) thereof, received money's worth in the form of free liquor in violation of WAC 314-12-140(2).

Enforcement and the Licensee wish to enter into a settlement agreement concerning the above-referenced AVN.




