1 thirty (30) days of the date of this final order of the Washington State Liquor Control Board.



HAPPOLD, Assistant Attorney General, and SAO DEM CORPORATION d/b/a SAO DEM (Licensee) of Kent, Washington, through its representative, SALVADOR VASQUEZ, hereby enter into this stipulated settlement agreement (Agreement) for Liquor Control Board Case No. 23,887.

I. INTRODUCTION

1. The Washington State Liquor Control Board Enforcement Division issued to the Licensee, Administrative Violation Notice (AVN) No. 2M1230C, alleging that on or about August 19, 2011, the above-named Licensee, or an employee thereof, sold and/or allowed liquor to be consumed on the premises between the hours of 2 a.m. and 6 a.m., contrary to WAC 314-11-070.



5 8. The parties recognize that this settlement agreement is subject to approval by
6 the Washington State Liquor Control Board.

7 9. The undersigned parties declare that the terms of this Settlement Agreement are
8 completely read, wholly understood, and voluntarily accepted for the purpose of making a full
9 and final compromise and settlement of any and all violations arising from the above-
10 referenced AVN.


