ONE TEAM ONE DREAM d/b/a FUEL SPORTS BAR & ROCKHOUSE (Licensee) of Wenatchee, Washington, through its representative, BRYAN JOHNSTONE, and the parties having voluntarily entered into a stipulated settlement agreement for case number 23,893, and the Board having considered the Stipulated Settlement Agreement and Enforcement's Memorandum recommending acceptance of the Stipulated Settlement Agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED that the AVN for Case Number 23,893 is sustained and the Licensee shall pay a monetary penalty of three hundred dollar (\$300) to be paid within thirty

HAPPOLD, Assistant Attorney General, and O.D.O.T. ONE TEAM ONE DREAM d/b/a FUEL SPORTS BAR & ROCKHOUSE (Licensee) of Wenatchee, Washington, through its representative, Bryan Johnstone, hereby enter into this stipulated settlement agreement (Agreement) for Liquor Control Board Case No. 23,893.

I. INTRODUCTION

1. The Washington State Liquor Control Board Enforcement Division issued to the Licensee, Administrative Violation Notice (AVN) No. 4E1224A, alleging that on or about August 12, 2011, the above-named Licensee, or an employee thereof, sold, allowed, and/or permitted an apparently intoxicated person(s) to consume liquor and/or possess liquor on the licensed premises, contrary to RCW 66.44.200(1).




