MAJUMDAR, and the parties having voluntarily entered into a stipulated settlement agreement for case number 23,894, and the Board having considered the Stipulated Settlement Agreement and Enforcement's Memorandum recommending acceptance of the Stipulated Settlement Agreement, and the Board having had the opportunity to review the file materials maintained in this case, now therefore:

IT IS HEREBY ORDERED that the AVN for Case Number 23,894 is sustained and the Licensee shall pay a monetary penalty of five hundred dollar (\$500) to be paid within thirty

1 (30) days of the date of this final order of the Washington State Liquor Control Board. The
2 payments shall be sent to:



MAJUMDAR, hereby enter into this stipulated settlement agreement (Agreement) for Liquor Control Board Case No. 23,894.

I. INTRODUCTION

1. The Washington State Liquor Control Board Enforcement Division issued to the Licensee, Administrative Violation Notice (AVN) No. 3N1227A, alleging that on or about July 30, 2011, the above-named Licensee or employee(s) thereof, gave, sold or otherwise supplied liquor to a person under twenty-one (21) years of age, contrary to RCW 66.44.270(1).




