STIPULATED SETTLEMENT
AGREEMENT

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General and STEPHANIE U. HAPPOLD, Assistant Attorney General, and CJD, INC., d/b/a NOEL'S RESTAURANT (Licensee) of Edgewood, Washington, through its representative, CRYSTAL JUNG, hereby enter into this stipulated settlement agreement (Agreement) for Liquor Control Board Case No. 23,907.

I. INTRODUCTION

1. The Washington State Liquor Control Board Enforcement Division issued to the Licensee, Administrative Violation Notice (AVN) No. 1Q1270A, alleging that on or about September 27, 2011, the above-named Licensee did not have the required food service available contrary to WAC 314-02.035.

2. Enforcement and the Licensee wish to enter into an Agreement concerning the above-referenced AVN.

1 **II. AGREEMENT OF THE PARTIES**

2 Enforcement and the Licensee agree to the following:

3 1. The parties enter into this Agreement to avoid the time and expense of further
4 litigation.

5 2. The Licensee explicitly waives the right of further administrative review of all
6 matters related to the above-referenced AVN. Furthermore, the Licensee hereby voluntarily
7 withdraws its request for a hearing in this matter.

8 3. This Agreement constitutes the final written expression of all the terms of this
9 agreement and is a complete and exclusive statement of these terms, and shall be effective
10 when signed by all parties and/or their legal representatives.

11 4. The Licensee admits to the violation in the above-referenced AVN, that is, on or
12 about September 27, 2011, the above-named Licensee did not have the required food service
13 available contrary to WAC 314-02-035.

14 5. The parties agree that this violation would be the first violation pursuant to
15 WAC 314-29-025 within a twenty-four (24) month period, which carries a standard penalty of a
16 five (5) day suspension of the liquor license, or two hundred fifty dollars (\$250) monetary
17 penalty.

18 6. The Licensee admits that subsequent to the issuance of the AVN and her request
19 for an administrative hearing, Licensee vacated the premises and ceased all operations under
20 the license.

21 7. The parties agree that the standard penalty of 5-days suspension or a \$250 fee is
22 no longer a viable option, as the Licensee has ceased operations under the license. The parties
23 therefore agree that there will be no assessment of any fees or suspension associated with this
24 violation.

25 8. The parties recognize that this settlement agreement is subject to approval by
26 the Washington State Liquor Control Board.


1 9. The undersigned parties declare that the terms of this Settlement Agreement are

3 and final compromise and settlement of any and all violations arising from the above-
4 referenced AVN.


