KIM, hereby enter into this stipulated settlement agreement (Agreement) for Liquor Control Board Case No. 23,932.

**I. INTRODUCTION**

1. Enforcement issued to the Licensee, Administrative Violation Notice (AVN) No. 1S1287D, alleging that on or about October 14, 2011, the above-named Licensee, or an employee(s) thereof, gave, sold and/or supplied liquor to a person under the age of twenty-one (21), contrary to RCW 66.44.270(1).

any reason, the standard penalty of a thirty (30) days suspension for the above-referenced violation shall be imposed.


