MCKENNA, Attorney General, and MARISA E. BROGGEL, Assistant Attorney General, and SUSIE'S SALOON, INC. d/b/a SUSIE'S BOURBON STREET BISTRO & BAR (Licensee), represented by and through SUSAN ROARK, Chairman and President of Licensee, and the parties having voluntarily entered into a stipulated settlement agreement for Washington State Liquor Control Board (Board) Case No. 23,942 arising from Administrative Violation Notice (AVN) No. 4F1349A, and the Board having considered the stipulated settlement agreement and Enforcement's

1 memorandum recommending acceptance of the stipulated settlement agreement, and the Board  
2 having had the opportunity to review the file materials maintained in this case, now, therefore:

3 IT IS HEREBY ORDERED that the allegation set forth in AVN No. 4F1349A, to wit:  
4 that on or around December 15, 2011, the Licensee or employee(s) thereof did not have the  
5 required Mandatory Alcohol Server Training (MAST) Permit in violation of WAC 314-17-030  
6 is sustained.


7 IT IS FURTHER ORDERED that, within thirty (30) days of the date of this order,  
8 Licensee shall pay a monetary penalty of five hundred dollars (\$500) to:

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and MARISA E. BROGGEL, Assistant Attorney General, and SUSIE'S SALOON, INC. d/b/a SUSIE'S BOURBON STREET BISTRO & BAR (Licensee), represented by and through SUSAN ROARK, Chairman and President of Licensee, hereby enter into this stipulated settlement agreement for Washington State Liquor Control Board (Board) Case No. 23,942, arising from Administrative Violation Notice (AVN) No. 4F1349A.

**I. INTRODUCTION**

1. The Washington State Liquor Control Board Enforcement and Education Division issued AVN No. 4F1349A to the Licensee, alleging that on or around December 15, 2011, the Licensee or employee(s) thereof did not have the required Mandatory Alcohol Server Training (MAST) Permit, in violation of WAC 314-17-030.

1 **II. AGREEMENT OF THE PARTIES**

2 Prior to scheduling an administrative hearing in this matter, Enforcement and the  
3 Licensee have agreed to enter into the following Stipulated Settlement Agreement (Agreement)  
4 concerning the above-referenced AVN. Enforcement and the Licensee agree to the following:

5 1. Enforcement and the Licensee enter into this Agreement to avoid the time and  
6 expense of litigation.

7 2. The Licensee hereby voluntarily withdraws its request for a hearing in this  
8 matter.

9 3. The Licensee explicitly waives the right to further administrative review of all  
10 matters related to the above-referenced AVN No. 4F1349A.

11 4. This Agreement constitutes the final written expression of all the terms of this  
12 Agreement and is a complete and exclusive statement of these terms.

13 5. The Licensee admits to the violation set forth in the above-referenced AVN  
14 No. 4F1349A. Specifically, the Licensee admits that on or around December 15, 2011, the  
15 Licensee and/or at least one employee(s) thereof (Ronnie L. Turner) failed to have obtained a  
16 MAST permit(s), as required by and in violation of WAC 314-17-030.

17 6. The parties acknowledge that the above-referenced violation is the Licensee's  
18 first violation of this type within a twenty-four (24) month period, for which the penalty is  
19 suspension of the Licensee's liquor license for five (5) days or a monetary penalty of five  
20 hundred dollars (\$500).

21 7. The parties acknowledge that Ronnie L. Turner, employee of the Licensee, was  
22 issued MAST permit no. 120 492 915 on or around December 21, 2011, and that this MAST  
23 permit expires on January 1, 2017.


24 8. The Licensee agrees to pay a monetary penalty of five hundred dollars (\$500)  
25 for the above-referenced violation. The Licensee agrees to pay this penalty in full within thirty

1 (30) days of the date of the Final Order of the Board, no later than 4:00 p.m. on the applicable


