16 Holder), and the parties having voluntarily entered into a stipulated settlement agreement for
17 case number 24,056, and the Board having considered the Stipulated Settlement Agreement
18 and Enforcement's Memorandum recommending acceptance of the Stipulated Settlement
19 Agreement, and the Board having had the opportunity to review the file materials maintained
20 in this case, now therefore:


21 IT IS HEREBY ORDERED that the Stipulated Settlement Agreement in the above

15 The Washington State Liquor Control Board Education and Enforcement Division
16 (Enforcement), by and through its attorneys ROBERT M. MCKENNA, Attorney General, and
17 ISAAC WILLIAMSON, Assistant Attorney General, and JORDAN ZIRIANS, Permit Holder,
18 hereby enter into this stipulated settlement agreement for Washington State Liquor Control
19 Board (Board) Case No. 24,056, arising from Administrative Violation Notice (AVN) No.
20 2E2001B.

21 **I. INTRODUCTION**

22 The Washington State Liquor Control Board Enforcement and Education Division
23 issued AVN No. 2E2001B to the Permit Holder, alleging that on or around January 1, 2012,
24 the Permit Holder sold liquor to a person apparently under the influence of liquor or allowed a
25 person apparently under the influence of liquor to possess or consume liquor on the licensed
26 premises, contrary to RCW 66.44.200 and WAC 314-11-035.

1 8. In the event that the Permit Holder fails to make a full or timely payment of the
2 monetary penalty, as set out and required by Section II, Paragraph 7, the Permit Holder shall be
3 subject to the penalties as references in Section II, Paragraph 6.

4 9. The parties recognize that this settlement agreement is subject to approval by
5 the Board.


