THIS MATTER having come before the Washington State Liquor Control Board (Board) and the Washington State Liquor Control Board Education and Enforcement Division (Enforcement) by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and MARISA E. BROGGEL, Assistant Attorney General, and FUN TIME PROMOTIONS, INC. d/b/a SKAGIT SPEEDWAY (Licensee), represented by and through STEVE BEITLER, and the parties having voluntarily entered into a stipulated settlement agreement for Administrative Violation Notice (AVN) No. 3B1213A, Case No. 24,069, and the Board having considered the stipulated settlement agreement and Enforcement's memorandum recommending acceptance of the stipulated settlement agreement, and the Board having had the opportunity to review the file materials maintained in this case, now, therefore:

IT IS HEREBY ORDERED that the allegations set forth in AVN No. 3B1213A, to wit: that on or about August 1, 2011, the above-named Licensee had effected a change in its

1 corporate officer(s) in at least 2003 without notification to or approval by the Board, in  
2 violation of WAC 314-12-070 and WAC 314-07-080, is sustained.

3 IT IS FURTHER ORDERED that the Licensee shall pay a monetary penalty of three  
4 hundred dollars (\$300) within thirty (30) days of this order, to:



14 In the event the Licensee fails to make full payment of the monetary penalty within  
15 thirty (30) days of this order, and/or in the event the Licensee fails to report to and obtain  
16 approval of the Board for the change in corporate officer(s) within ninety (90) days of this  
17 order, the Licensee shall serve a five (5) day suspension of its liquor license, the dates and time  
18 of which shall be set by the Washington State Liquor Control Board.

The Washington State Liquor Control Board Education and Enforcement Division (Enforcement), by and through its attorneys, ROBERT M. MCKENNA, Attorney General, and MARISA E. BROGGEL, Assistant Attorney General, and FUN TIME PROMOTIONS, INC. d/b/a SKAGIT SPEEDWAY (Licensee), represented by and through STEVE BEITLER, hereby enter into this stipulated settlement agreement for Washington State Liquor Control Board (Board) Case No. 24,069, arising from Administrative Violation Notice (AVN) No. 3B1213A.

**I. INTRODUCTION**

The Washington State Liquor Control Board Enforcement and Education Division issued AVN No. 3B1213A to the Licensee, alleging that on or around August 1, 2011, the Board became aware that a change in corporate officer(s) for the Licensee had occurred in 2003, for which the Licensee failed to notify and/or obtain approval of the Board, in violation of WAC 314-12-070 and WAC 314-07-080.

1 Enforcement and the Licensee wish to enter into a settlement agreement concerning the  
2 above-referenced AVN.

3  
4 **II. AGREEMENT OF THE PARTIES**

5 Enforcement and the Licensee agree to the following:

6 1. Enforcement and the Licensee enter into this Agreement to avoid the time and  
7 expense of further litigation.

8 2. The Licensee explicitly waives the right to further administrative review of all  
9 matters related to the above-referenced violation.

10 3. This Agreement constitutes the final written expression of all the terms of this  
11 Agreement and is a complete and exclusive statement of these terms.

12 4. The Licensee stipulates to the violation set forth in AVN No. 3B1213A.  
13 Specifically, the Licensee admits that or around August 1, 2011, the Licensee effected a  
14 change in its corporate officer(s) in at least 2003 without notification to or approval of the  
15 Board, in violation of WAC 314-12-070 and WAC 314-07-080.

16 5. The Licensee admits that this is the Licensee's first violation of this type within  
17 a twenty-four (24) month period, for which the standard penalty is a monetary penalty of five  
18 hundred dollars (\$500) or suspension of the Licensee's liquor license for five (5) days.

19 6. The Licensee agrees to pay a monetary penalty of three hundred dollars (\$300)  
20 within thirty (30) days of the date of the Final Order of the Board, no later than 4:00 p.m. on  
21 the applicable date, for the violation stipulated to in Section II, Paragraph 4. Payment shall be

1           7.     The Licensee further agrees to take all necessary steps pursuant to Title 66  
2 RCW and/or Title 314 WAC to obtain approval by the Board for the change in corporate  
3 officer(s), within ninety (90) days of the date of the Final Order of the Board.

4           8.     In the event that the Licensee fails to make the full payment of the monetary  
5 penalty on time, as set out and required by Section II, Paragraph 6, and/or fails to obtain  
6 approval for the change in corporate officer(s) as set out and required by Section II,  
7 Paragraph 7, the Licensee shall be subject to a five (5) day suspension of its liquor license, the  
8 dates and times of suspension to be determined by the Board.

9           9.     The parties recognize that this Agreement is subject to approval by the Board.

10          10.    The undersigned parties declare that the terms of this Agreement are  
11 completely read, wholly understood, and voluntarily accepted for the purpose of making a full  
12 and final compromise and settlement of any and all violations arising from the above-  
13 referenced Complaint.


